1) **Pumping Report**:

Town Administrator Keiser warned the Commission that one needs to be cautious with revenue reduction and stated that the Town of Jamestown is a conservation model for the State. Commission consensus: To have a greater discussion regarding infrastructure and the fire suppression/ hydrant rental fee and to table discussion on this matter until a later date.

2) Request for waiver of utility hook-up fees re: West Ferry bathroom

The Town Administrator recommended that the Commission waive the water (\$3,000.) and sewer (\$3,000) hook up fees for the new West Ferry bathroom. Following clarification of a few items, motion was made by Commissioner Bowen, seconded by Commissioner White to waive the hook up fees for the new bathroom at West Ferry. So unanimously voted.
