

Dear Residents, Businesses, and Community Partners,

Rhode Island's percent positivity rate, as it relates to COVID-19, is down from last week, now 1.9% (2.3% last week).

Rhode Island has now administered over 881,000 vaccines. *The fastest way to end this pandemic and safely re-open our economy is by getting vaccinated.* If you are 16 years of age or older, book your appointment today on <u>VaccinateRLorg</u> or call 844-930-1779 or 211.

Starting this week, three state vaccination sites now offer walk-up vaccinations (Sockanosset Cross Roads in Cranston, Dunkin' Donuts Center in Providence, and 1400 West Main Road in Middletown).

Vaccinations for both North Kingstown and Narragansett High Schools will be offering the Pfizer vaccine to all students age 16-18. Students/ parents will receive notice from their respective schools. These are the scheduled dates for each school:

North Kingstown:

1st dose: May 7 from 2:00 p.m. to 7:00 p.m. 2nd dose: May 28 from 2:00 p.m. to 7:00 p.m.

They will NOT be offering this opportunity to parents.

Narragansett:

1st dose: May 5 from Noon to 4:00 p.m. 2nd dose: May 26 from Noon to 4:00 p.m.

They will be offering this opportunity to parents.

COVID-19 Vaccine Information

Current Eligibility: All Rhode Islanders ages 16 and older, and those that work in R.I. are eligible.

Options for Rhode Islanders 16+ to be vaccinated:

- 1. **State Sites:** Register for a vaccine here or call 844-930-1779.
 - a. Site in Cranston, Providence and Middletown now offering walk up services.

- 2. **Regional Sites:** Located in East Providence, Johnston and Westerly. Appointments are required. Visit https://www.vaccinateri.org/.
- 3. Pharmacies: CVS, Walgreens, Walmart, Stop and Shop, and independent pharmacies.
- 4. Lifespan Clinic and Care New England Clinic

Johnson and Johnson Vaccine: RIDOH will resume the administration of Johnson & Johnson COVID-19 vaccine. This decision was made following the <u>recommendation</u> last week by the FDA and the CDC. Learn more about this in <u>RIDOH's press release</u>.

Transportation: R.I. Public Transit Authority is offering free fares to those going to and from vaccination appointments. People with vaccine appointments can email CustomerService@RIPTA.com or call 401-781-9400.

Homebound Vaccinations: Those that are homebound and filled out the state's survey may receive calls from one of these three vendors: MedTech, Alert Ambulance, and PACERI. If you are homebound and have not requested a vaccine, please do so through this survey.
