


Survey: Town of Jamestown - 2010 Community Survey



How do you feel about the following goal from the 2004 Comprehensive Community Plan? Protect natural vegetation and wildlife habitat wherever possible thoughout Town.




Should the Town make it a priority to protect diverse wildlife habitat wherever possible on public lands?





Are you in favor of a street tree planting/replacement program along major roads in Jamestown?





Do you feel Jamestown has adequate active recreation?





Does Jamestown have adequate facilities for boating?







Do you support creating historic districts on the Island for the purpose of local building regulation?



Some of the question lacked specificty so I might have answered differently. EX. I

1 would have agreed with owner occupied duplex dwellings but not absent landlord housing which could become instant slums.
The lamostawa Becreation Dept spends pacefy a much as it takes in from food.

The Jamestown Recreation Dept spends nearly s much as it takes in from fees. I do support the recreation programs -- but I don't think it's completely accurate to say that the income from Ft. Getty provides \$1/4 million to the town's general

fund. Are you sure that this figure is accurate?

I and my family love living in Jamestown and wish to continue to do so. But,
 house prices are high and we may not be able to afford to live here. My wife and I are raising a young family and she is unable to work to earn money because

someone needs to stay with the children. Land use is the key to maintaining the character of Jamestown. That character has moved upscale and we are moving towards being a gated municipality. We

I don't mind the daytime and early evening noise (Harley Davidson bikes excluded), but it is the night and early morning noise that is becoming unbearable (loud music at the Narragansett Bar until 1am, drunk people laughing and screaming until 1:30am, trash trucks arriving between 4 and 5am, delivery trucks starting at 6am). Since the commercial district is also the location of the "lower income rentals and housing," I would like to propose a modification to the

This allows for at least seven uninterrupted hours of sleep. If the noise ordinance is not changed, myself and the other member of my household will probably have to move out of Jamestown. I don't believe we should try to have non residents live on one of the most beautiful vistas on our island for the summer when our residents do not have any place that has this access. We should develop Fort

Getty for our residents to enjoy just as Narragansett has done with its water access for its citizens rather than opening up this access for non residents.

1 deer on the North end, it is out of control Great job keeping our streets plowed in winter Thx


Thank you for your efforts and the task of maintaining the "funky" small town charactoer that is the charm of the "island of Jamewwtown Farmland is all part of

and turned other towns and cities and government. Cut down on things that I have mentioned.


