2 **Sec. 38-111. - Use of rifled firearm while hunting.**

3 No person shall, while hunting within the town, use a rifled firearm, other than a shotgun
4 outfitted with a rifled barrel or a muzzleloader with a rifled barrel.

5 **Sec. 38-112. Definitions.**

6 The following definitions shall have the following meanings for the purposes of this chapter:

7 “Building”: any structure used or intended for supporting or sheltering any use or occupancy,
8 including but not limited to a dwelling, and or accessory building or structure.

9 “Discharge”: the operation of a firearm as to cause the ignition of the powder charge with or
10 without the expulsion of a projectile from the firearm.

11 "Firearm": includes any machine gun, pistol, rifle, air rifle, air pistol, "blank gun," "BB gun," or
12 other instrument from which steel or metal projectiles are propelled, or which may readily be
13 converted to expel a projectile, except crossbows, recurve, compound, or longbows, and except
14 instruments propelling projectiles which are designed or normally used for a primary purpose
15 other than as a weapon. The frame or receiver of the weapon shall be construed as a firearm
16 under the provisions of this section.

17 “Recreational Target Range”: a non-commercial target range which may be located indoors or
18 outdoors to practice the discharge of weapons aimed at a target.

19 **Sec. 38-113 Firearm Discharge.**

20 Conanicut Island is determined and declared to be a compact area as that term is set forth
21 pursuant to the relevant provisions of the R.I. General Laws at Title 11, Chapter 47, Section 50,
22 as amended, except for those areas of the Island with the zoning designation of RR-200 or RR-
23 80, as set forth in the Jamestown Code of Ordinances, Chapter 82 – Zoning, at 82-301 and the
24 Official Zoning Map, as amended. No person, not being at the time under police or military duty,
25 shall Discharge any Firearm on Conanicut Island in the Town of Jamestown, except as follows:

- 26 1. Legal hunting activity as defined by state and local regulations.
- 27 2. Target shooting on private property by the property owner or guest with written
28 permission of the property owner on a Recreational Target Range.
- 29 3. Use of a Recreational Target Range is restricted to the time period between 10:00 AM
30 to 6:00 PM, Wednesday through Saturday; provided, however, that all activity must
31 cease 30 minutes before sunset on a year-round basis.
- 32 4. All prudent safety measures shall be exercised to protect the public health, safety and
33 welfare.
- 34 5. The point of Discharge of any Firearm and the point of impact from any target, berm
35 or backstop shall be a minimum distance of 500’ feet from any Building.
- 36 6. The point of Discharge of any Firearm and the point of impact from any target, berm
37 or backstop may be less than that set forth in paragraph 5, supra, if, and only if, the

1 owner or owners of any Building within 500' from the point of Discharge and the
2 point of impact from a target, berm or backstop provides written permission for the
3 point of Discharge and the point of impact from any target, berm or backstop being
4 less than that required.

- 5 7. In no case shall any target, berm or backstop be located greater than 100' from any
6 point of Discharge of any Firearm.

7
8 No person shall Discharge any Firearm in such fashion that the shot, bullets, arrows, darts or
9 other missiles shall in their flight carry over, along or across the land of another, any public
10 roadway, designated public walking path, access way, sidewalk, hiking trail, park area, or bike
11 path, into which they shall not have written permission of the owner and occupant thereof to
12 shoot. Such written permission shall be carried on the person at all times when engaged in the
13 activity and shall be shown and exhibited upon request by the police.

14 **Sec 38-114. Use of weapons in self-defense and hunting.**

15 No provision of this chapter shall be construed as prohibiting the use of Firearms by licensed
16 armed guards or by private persons in the Town for the protection or defense of person or
17 property and/or hunting in accordance with applicable provisions of the General Laws.

18 **Sec. 38-115. Enforcement.**

19 Any person violating the provisions of this section shall be punished as provided in Section 1-15.

Dear Council Members,

I ask you to please ban shooting ranges on our island.

I believe that everyone has a right to their hobbies and that zoned commercial shooting ranges have every right to exist, but I object to recreational shooting ranges anywhere on Conanicut Island for the following reasons:

People walk their properties, kids explore woods, pets wander — there are a gazillion reasons and ways to enjoy Jamestown. The beauty of this island is incomparable, and we are so fortunate to live in a quiet, peaceful place. People come many miles to experience what we have every day. Why would we permit this increasingly rare solitude and enjoyment of the outdoors to be interrupted by gun shots and pursuant alarm? Especially when there are at least 3 safe, protected, and monitored ranges with multiple shooting opportunities within 10 miles.

With a population of 6100 people living in 9.4 sq. miles, surely the density alone precludes the discharge of firearms. People do not stay protected in their homes 24/7. Jamestown is not a place of wide open, flat spaces. How can a shooter see the distance a bullet can go, anticipate what he or she can not see nor guarantee that there will be no mishaps? They can not, which is precisely why commercial shooting ranges are constructed and zoned the way they are.

Jamestown should not provide what amounts to a convenience for a few when the discharge of firearms will clearly disturb the peace, create undo anxiety, and risk death, damage or injury. This has nothing to do with taking away the right to bear arms, nor taking away the right to use property as owner's see fit. As mentioned, there are quite a few safe ranges within easy driving distance. In regards to zoning, it is clear to me that allowing shooting ranges on any land in Jamestown, interferes with existing uses, and does nothing to preserve the character of the island and its community.

Dear Jamestown Town Council Members:

I write to voice my deep concern over the possibility of allowing shooting in the RR80 and RR200 zones of Jamestown and to encourage a total ban of shooting in these zones. Though these areas generally contain larger plots of land, they are nonetheless too closely settled to make me feel comfortable having firearms being used. Many of the properties in our neighborhood in the Dumplings, while zoned RR80, are non-conforming. My own property is way too close to most of my neighbors for me to feel comfortable having anyone use a firearm either on my property or on theirs. There are just too many opportunities for an accident to happen. Whereas on a large farm where a stray bullet might simply go a bit farther off into a field or into a wooded area, in our neighborhood and others zoned similarly to ours, a stray bullet could easily land very close to a neighbor's living space. With so many friends, relatives, and youths all over Jamestown in the summer months, I fear that a tragedy is waiting to happen.

My mother's best friend and next-door neighbor growing up nearly killed her father in a freak accident involving a firearm. My grandfather happened, by complete chance, to bend over to pick something up from the ground as a bullet whizzed through the window near him and struck the wall above him. I'm sure there are so many close calls similar to this, and through no one's fault or intention, innocent people are hurt or killed.

While I don't want to limit individuals' rights to use their firearms legally, I think it is their duty as well as ours to ensure that they do so in the safest possible manner. I can see no place for firearms in neighborhoods. With Jamestown ongoing reports of low to no crime, I can't make an argument for the right to use firearms in these areas even in self defense.

I urge you to maintain a total ban on firearms in our neighborhoods.

I am sure you are getting bombarded with opinions regarding the target shooting issue, but thought I'd add my opinion anyway.

While target shooting at homes sounds like someone doing what they want on their own land and therefore OK, I think it is inherently dangerous. When I was in Washington DC for a summer job in 1975 during my college years, a man in my New Jersey hometown was working on his roof on the Fourth of July and was killed from an errant shot fired from about three miles away. I Googled the incident last week and attach one of the newspaper stories of the event. I emphasize that a rifle was fired from three miles away and killed somebody just outside in the wrong spot as the bullet returned to land.

And there are a lot of other stories like these.

Suspect Charged In July 4 Shooting

Wilbert Schallis of Morris Township has been charged with hindering police investigation in connection with the accidental death of Jean Boulanger as he was tarring the porch roof of his Shunpike home on July 4.

The suspect, who is 49, has been charged with four counts of obstructing justice and a single count of contributing to the delinquency of a minor.

These charges stem from the fact that Schallis gave false information to the police during the early part of the investigation, that he

tried to destroy the rifle which he fired the day of the shooting, and that he apparently allowed a minor to shoot the firearm.

Chatham Township police stress that it still has not been established that the rifle owned by the suspect was responsible for the accidental death. They are awaiting reports from ballistics experts at Trenton who are reconstructing a bullet which was shot by Schallis on July 4 to kill a snapping turtle near his home. This bullet, which was badly damaged when dug up, will then be com-

pared with the one taken from Mr. Boulanger's body.

In reviewing the sequence of the investigation, local police said that among the many calls received shortly after the incident occurred were some from witnesses who informed local headquarters that they had heard shots from the area in which the suspect lives setting the time about the hour it was reported that Mr. Boulanger had been shot. Results of a study by experts at Picatinny

Arsenal, who used computers in their tests, indicated that the bullet which caused the death had been fired in the same area.

With this information, the police returned to the home of the suspect who then admitted having fired a rifle and had discarded parts of it in an area in Great Swamp. A search for these has been only partially successful.

Schallis has been released on \$5,000 bond pending court appearance. Meanwhile, police will continue the investigation.

I completely support and love Jamestown's rural character, and ended up wanting to live here when I first stopped here in 1996. (I had driven through Jamestown non-stop via Rt 138 probably since the early 80's). I had a boat and the fellow watching it for me suggested keeping it at CMS, as Jamestown was a much more civil place than Newport. Man was he right. I will never forget the first time in '96 that I actually got off of 138 and drove south on North Rd pass the farms and windmill and then down Narragansett Ave. I was impressed. It was a long way from Jamaica, NY where I grew up. It had and still has a rural character, with great people and only it's 10 minutes from Newport. If you want to go there.

Here is where we disagree, as I can't connect rural character and people shooting handguns, rifles and high powered rifles in their backyard. My rural character provides safety for those living there. Our population has doubled since 1970 and continues to grow. There are three total containment shooting ranges 15-20 minutes away, two are brand new. It looks like Great Swamp is adding another new shooting range and probably starting construction this fall. That's 20-25 minutes away and I think it's free. People want to shoot and should be allowed to shoot, but at a safe place, not at pile of dirt 501' away from their neighbors house. I feel a nine mile square island with almost 6000 people on it is too small for backyard shooting.

In my mind it's a public safety issue. Of course the idea of listening to repetitive gun fire for hours at a unsupervised site close to my home is not my idea of mental or emotional safety.

I also think CILT has done a wonderful job of maintaining Jamestown's rural flavor but the proposed partial ban completely disrespects them, allowing them to be the place where misfires could end up and where people are encouraged to walk trails. I think a small .22 cal rifle can sent a bullet 3/4s of a mile according to the below chart. That's a lot more the 500'. I think that DEM allows hunters use .22s elsewhere but Jamestown doesn't because the island is to small. Not really sure.

I will try to put this in a nice way, the five or seven backyard shooters have had maybe 50 years of a free run, but that doesn't predict future safety and the population has doubled. I believe Jamestown won't loose its rural character if It bans target shooting as all of our surrounding towns did in one way or another 30 to 50 years ago for public safety reasons.

I've told you how I've admired what you and your family have done for Jamestown over the 20 years I've been here and I don't want this public disagreement between us to spike our friendship.

Dear Town Council Members,

Forgive me for pestering you once again so soon after the last meeting. This time my issue is private target shooting (April 10), and with it, recognition of the contradictions in viewing our community as rural vs. suburban.

I hope most of you know my views as a landowner on hunting, gun use and wildlife control – I am totally IN FAVOR!

I think hunting is appropriately regulated, RI gun law is entirely adequate, and wildlife control is an issue that we cannot ignore. The Tick Task Force is doing a good job but I would go further, and set up a system for appropriate coyote culling as well. I believe that between the misguided feeding, the suburbanization of the island and the amazing adaptability of coyotes to urban environments, we will need to carefully and professionally cull this population, as well as the deer, on an annual basis. In a suburban environment, these species no longer balance each other, and human intervention is the only solution.

That said, I think it's also time to recognize that we can no longer support backyard target shooting. For me, it's actually the exact same argument. The rural community for which we all feel such nostalgia is no longer a reality in Jamestown. At 5600 residents we have become too densely populated and we need to take appropriate measures to protect the human population.

I believe the total target shooting ban is the best answer, and that the partial ban is an absurdity which simply continues to avoid the issue. I have read most of the NRA handbook of guidelines and I don't see how we could possibly ask our local law enforcement to check each private range for assurances of sobriety and, I'm sorry to mention, senility or other issues of competent use, and still maintain safety standards. I'm fully aware that our local shooters are responsible and competent citizens. I think the Town has just been putting off and turning away from an issue that we can't continue to ignore, out of respect for this great generation of people who learned to shoot from their fathers and grandfathers. But sadly we just can't keep ignoring the issue on a densely-settled island.

Considering the limited proposal, where is the liability, where is the enforcement capability, how are questions like berm heights, effective containment, or responsible establishment of new ranges to be determined? Would

we limit weapons by caliber, would we ask for red flags to be put up during shooting hours, would we ask for signed waivers, would we in fact demand full conformation to the NRA guidelines? And how could the Town possibly expect to enforce all that on multiple properties, or as the proposal now stands, throughout the rural zone?

Sports-men and -women have great nearby alternatives in the Great Swamp and Newport Rifle Club. Maybe we do want to consider building such a facility here. But in the meantime it is the Town Council's responsibility to establish necessary safeguards for the public, and the partial ban with its totally inadequate 500' setback and lack of any containment standards utterly fails to do so.

We can't allow nostalgia for our rural past to cloud a public safety issue – it's as simple as that.

Re: Target Shooting

Dear Town Council,

I was part of the group that met with Chief Mello in 2014; I have been silent in this matter but I can no longer be silent. I am writing to you at your private residence because this matter affects me at my private residence. This is a safety issue in conjunction with imposing on our quiet enjoyment of our property and neighborhood. The Wildflower Lane site caused the initial complaint and basically ruined it for all the other private sites. The Wildflower site is 350 feet from my house on East Shore Road.

The property owner and her son did not take into consideration the neighbors. There is a young family with two children and an elderly widow at the base of Wildflower Lane. It is unnerving to hear the shots; it affects our families and our pets. None of you live in the R80 zone; have any of you experienced the repetitive sounds of random gun shots adjacent to your property? A mound of dirt does not classify as a gun range. I listened to John Caito shoot with his friends; they did not shoot one at a time. I was visiting a neighbor one night who also is a friend of Johns and I spoke to them about the gun shots, I referenced to a Sunday evening when the shots went on for 1.5 hours continuously with two guns firing at the same time. The friend said; oh that is because I was there with him. I said "I guess he has a mound of dirt he shoots into"; the friend said "no he shoots into the woods". Obviously this is not a controlled, safe environment. I have no reason to alter the truth of this conversation, I was shocked.

I have one question, if you allow this to continue and on a Sunday afternoon a resident of Jamestown is driving home from the transfer station or just driving downtown to get the paper and that resident gets a random bullet in their head from one of range sites, are you/will you take responsibility for that? You are the town government if you say this is ok you are taking on the liability. That means my tax dollars will be in jeopardy when the town is sued about this issue, basically the residents of Jamestown are taking on the liability.

There was shooting at the North Road site on Sunday April 2, it was loud and clear at my property. On Sunday April 9, when the shooting starts I will call all of you to come join me while my family tries to have a peaceful birthday dinner for my husband.

Please do not allow shooting a gun for personal pleasure to be an acceptable activity in Jamestown.
