

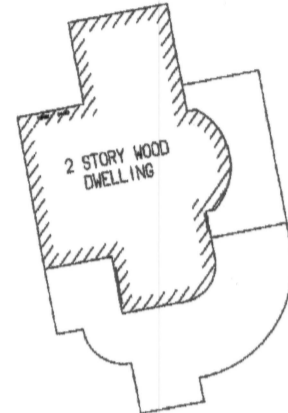

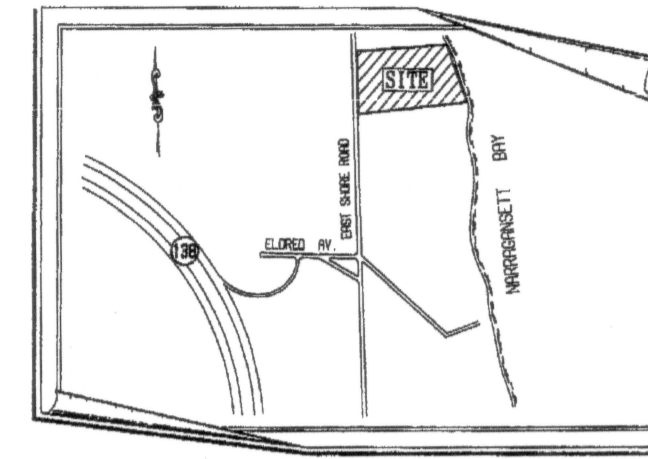


PARCEL A

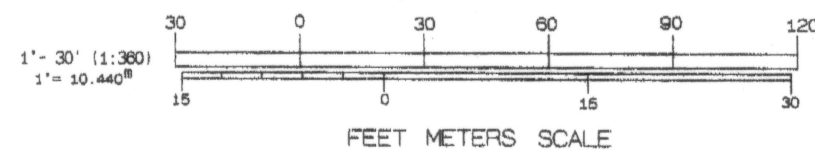
