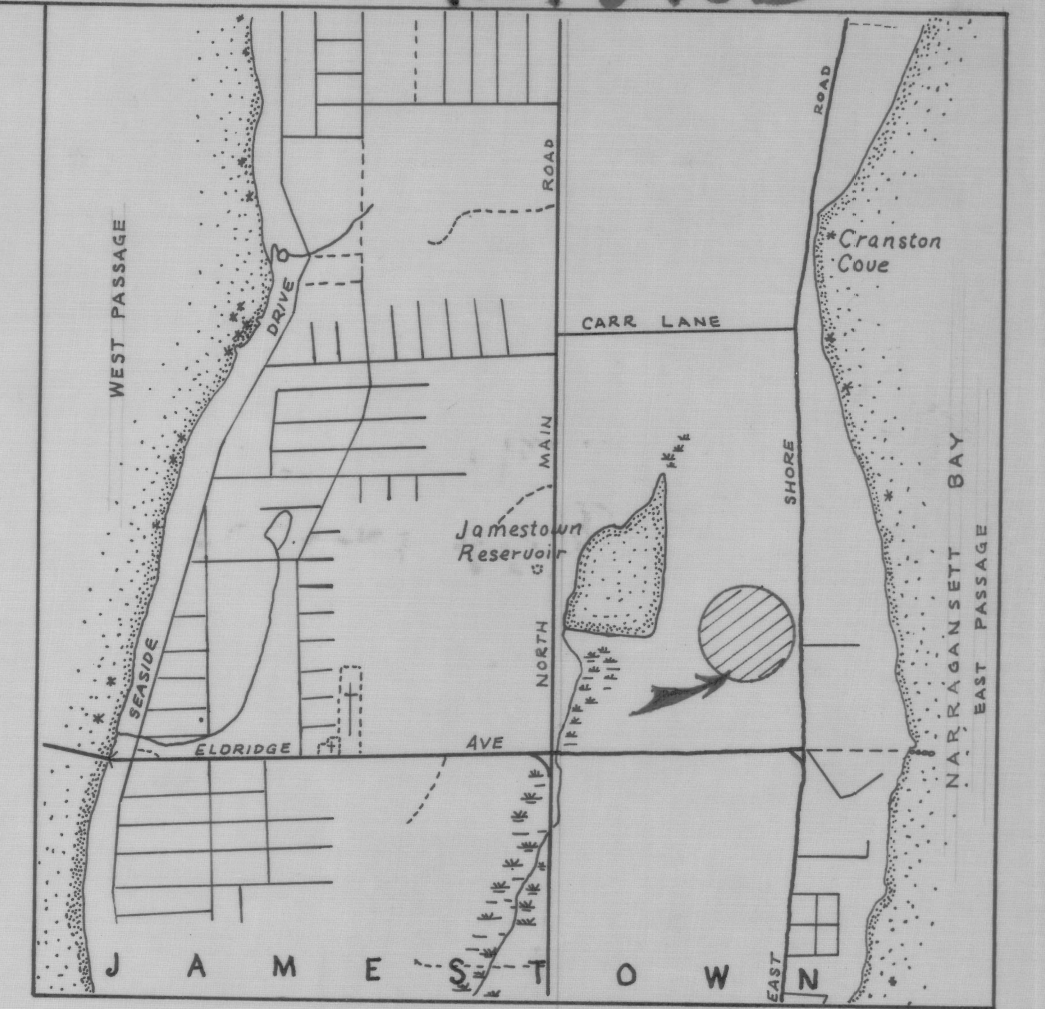

SCALE 1" = 2000

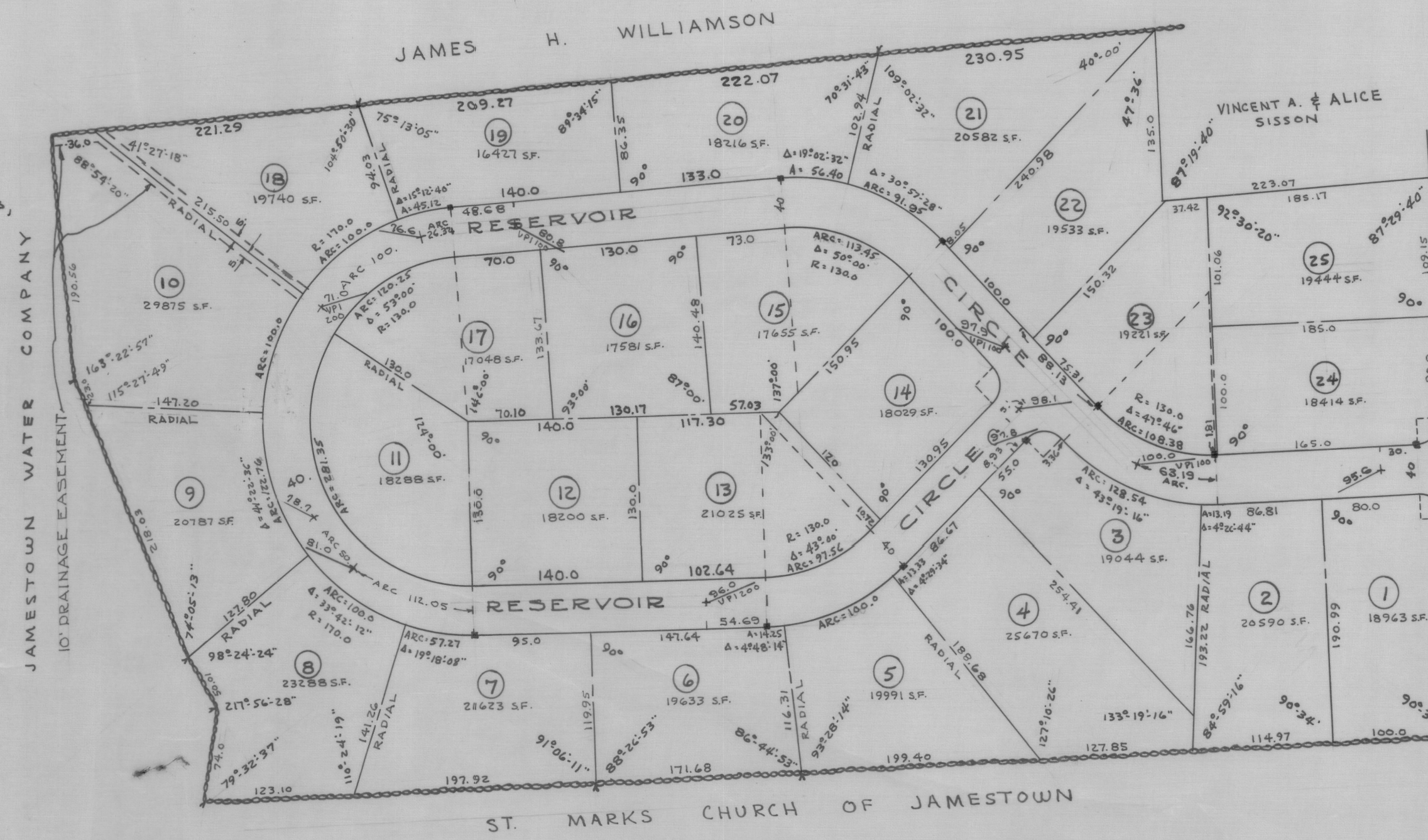

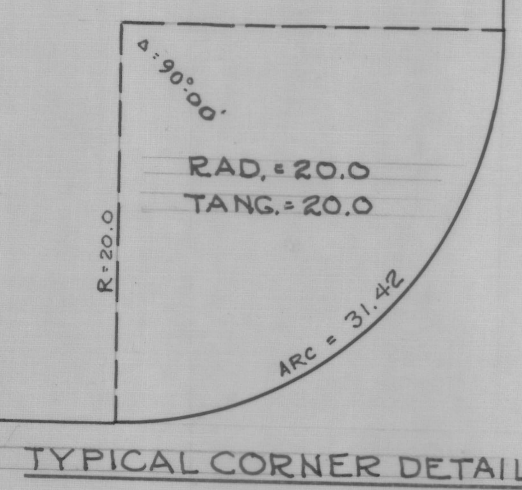


STATEMENT OF EASEMENT (SHOWN):
