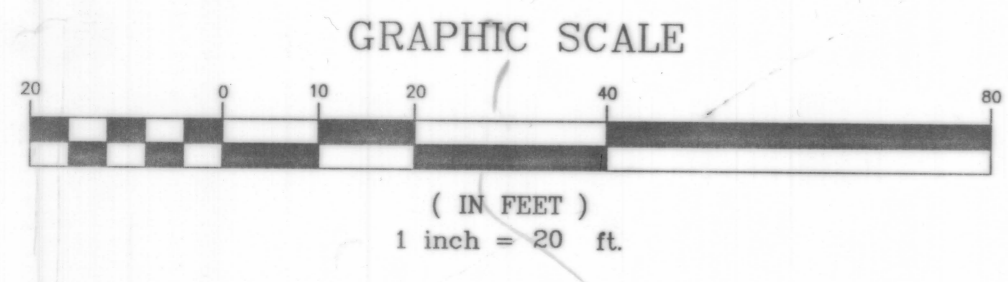

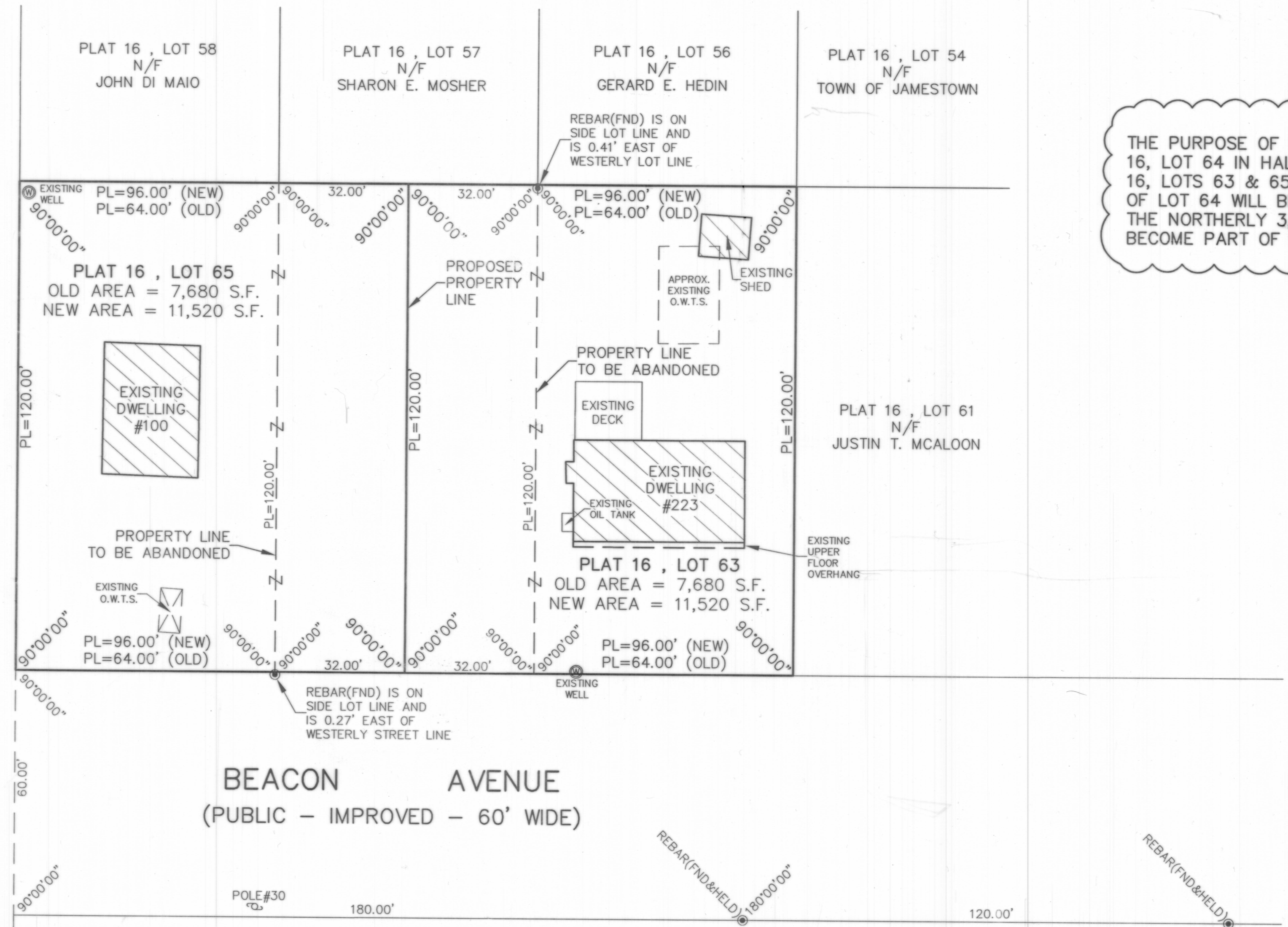
STREET INDEX
