Fort Getty Park Dry Storage Rules

Fort Getty Park offers 20 dry boat storage spaces for Jamestown residents with boats up to 30 ft. Parks and Recreation Management will have the final approval of any boats/trailers on site.

(Please initial on each line)

Storage Period: November 1st to May 1st each year _____

Payment: The \$750 rental fee must be paid in full by October 25th. Late payments will result in the forfeiture of the site. No prorated rates are available. _____

Damage Liability: Permit holders are responsible for any damage caused to their site or surrounding areas. The Town of Jamestown is not liable for damages caused by fire, theft, natural disasters, vandalism or other uncontrollable events. It is recommended that boat owners periodically check on their boat. Document and report issues to the Jamestown Parks and Recreation Department and/or Jamestown Police as necessary _____

Insurance: Permit holders must provide proof of insurance at time of application for their boats and trailers against loss or damage. _____

Registration: All boats and trailers must be properly registered. _____

Winterization: Boats must be winterized and covered with shrink-wrap or a boat cover before being stored. _____

Site Condition: The storage site must be left in good condition at the end of the rental period. _____

Trailer Parking: Boats must be stored on a registered trailer. Trailers must be parked with the hitch facing the road for emergency access. Adequate space between units must be maintained, and Park Management will determine the final trailer placement. _____

Prohibited Use: The storage site cannot be used for residency, business, or any form of occupation. _____

Transfer Restrictions: The permit cannot be transferred or sublet. _____

Emergency Contact: Permit holders must provide emergency contact information. _____

Commercial Vessels: For commercial vessels, the Town of Jamestown must be listed as an additional insured. _____

Hazardous Materials: All hazardous materials must be removed from boats before storage including fuel canisters, oil, or other loose hazardous/flammable materials. _____

Maintenance Restrictions: No work or maintenance is allowed on boats while in storage. _____

Hold Harmless and Indemnification Clause

As a condition of storing watercraft, trailers, or any other personal property at Fort Getty Park, the permit holder agrees to hold harmless, defend, and indemnify the Town of Jamestown, its officers, employees, and agents from any and all claims, actions, liabilities, damages, losses, or expenses arising from or related to the storage of said property. This includes, but is not limited to, loss or damage caused by fire, theft, natural disasters, or any other events beyond the control of the Town of Jamestown. The permit holder acknowledges that the Town of Jamestown is not responsible for any damage, loss, or destruction of stored items, and the permit holder assumes all risk associated with the storage of their property at this location.

The undersigned agrees to comply with the Fort Getty Seasonal Boat agreement rules and regulations, and engage in lawful behavior at all times. Failure to comply with the rules may result in permanently forfeit use of the boat site hereby granted, and future boat storage privileges at Fort Getty.
